TROOP B MEMBER WINS REVOLVER CONTEST

SYRACUSE, N. Y., Aug. 28.—Trooper Oliver Rathbun of Troop B stationed at Malone won the individual revolver championship of troops A, B, C, D, G, and K in the annual marksmanship competition of the State Troopers held at the Troop C range in Syracuse on August 26th, smashing the record of eight years standing with a card of 121 points out of a possible 170. The previous record was 118 points.

Trooper L. G. Fenelon of Troop K, White Plains, was awarded the medal for best rifle shot with a total of 104 points, Troop G of Troy with a gross score of 730 points was awarded the silver cup for the troop team scoring the greatest number of points in the day's shooting.

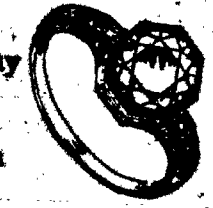

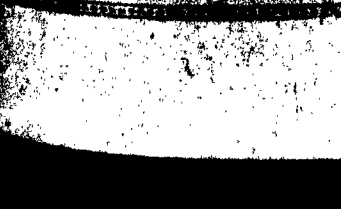
