Sayville, Oakdale parents question sump danger

Residents near a wax factory on Bourn Boulevard in Sayville said last Friday that a sump on the site has become a hazard for children in the neighborhood.

The sump adjacent to the Koster Keunen was plant, which produces products for cosmetic and industrial use, is a depository for byproducts of refining. "What comes out is like a thick, black mud," said Gary Clark, a spokesman for a group of concerned parents who say their children play near the sump. "If a kid wanders into that stuff, he could sink in the mire."

The sump is on Koster Keunen property and is separated from traffic on Bourn Boulevard by a heavy duty chain link fence. The fence is frequently destroyed by vandals seeking access to the factory or to surrounding woods. A spokesman for Koster Keunen said Wednesday that the fence had recently been repaired after a robbery and was now intact, but was "occasionally ripped down."

Clark said residents are concerned by the sump because it is next to the Edward J. Bosti elementary school. Though there have been no incidents reported to police or to Koster Keunen executives in which children have fallen into the sump, Clark said he and neighbors thought there was "potential danger" on the factory grounds. "The stuff has been checked and isn't toxic. That isn't the problem.

said the company maintained the fence "properly" and repaired it as quickly as possible whenever children or teens

The new ownership of the 1000 watt non-directional signal station, founded in 1955, signals emergence of Dennis R. Israel as a dominating figure in Long Island broadcasting. Israel (East End Communications President) just two years ago purchased WGLI Radio (1290 AM) in Babylon. He transformed it from a secondary station into a successful local news, talk, and information broadcast outlet reflecting dramatic increases in listenership and advertising sales in-

Israel indicates that he intends to retain the adult programming format of WRIV so successfully developed by the current General Manager, Jack Ellsworth of Patchogue.
